### **Care and Maintenance Fees for Cemetery and Monuments:**

A Care and Maintenance Fund (the "Fund") is a trust fund that helps to ensure the long-term upkeep of a cemetery. The cemetery is required by provincial legislation to make contributions to the Fund from the sale of all interment rights and upon the installation of a monument. Ontario Regulation 30/11 under the [Funeral, Burial and Cremation Services Act](#) sets out the amounts to be contributed to the Fund from the sale of each interment right, as well as the amounts to be contributed to the Fund upon the installation of a monument.

- From the sale price of an in-ground grave that is 24 square feet or larger, the contribution is either 40% of its price or \$290 – whichever is greater.
- From the sale price of an in-ground grave that is smaller than 24 square feet, the contribution is either 40% of its price or \$175 – whichever is greater.
- From the sale price of a niche, the contribution is either 15% of its price or \$165 – whichever is greater.
- After the sale of scattering rights in a scattering ground where there is more than one scattering rights holder, the contribution is either 15% of its price or \$30 – whichever is greater.
- Flat marker measuring less than 173 square inches – \$0.
- Flat marker measuring at least 173 square inches – \$100.
- Upright marker measuring 4 feet or less in height and 4 feet or less in length, including the base – \$200.
